

# Ireland Publishes Working Outline of National Action Plan on Business Human Rights

Deadline: 29 January 2016

The Irish Government decided on 24 June 2014 that Ireland would develop a national plan for the implementation of the UN Guiding Principles on Business and Human Rights (UNGPs). An inter-departmental working group was formed consisting of focal points from each Government Department and state agencies and, following consultations with civil society and business, a working outline of Ireland's Plan has now been prepared. The working outline of Ireland's Plan is published on the Department of Foreign Affairs & Trade website, www.dfa.ie. The National Plan on Business and Human Rights will build on the achievements of Ireland's National Plan on Corporate Social Responsibility which was published by the Department of Jobs, Enterprise and Innovation in April 2014.

Interested parties are invited to submit views on the working outline of Ireland's National Plan on Business and Human Rights by e-mail to the Human Rights Unit of the Department of Foreign Affairs and Trade at businesshr@dfa.ie (before 29 January 2016).





#### UNHCR Ends G4S Security Contracts in Jordan

The Boycott, Divestment and Sanctions movement announced a victory today as the United Nations High Commissioner for Refugees (UNHCR) in Jordan confirmed to journalists that it has not renewed security contracts with the British private security firm G4S. G4S is the world's largest private security company in the world, and has come under fire from campaigners for a range of grave human rights abuses, including deaths in custody at its prisons and detention centres in the UK, Australia and South Africa.

The United Nations Working Group on business and human rights undertook its first official visit to Brazil to examine the adverse impact of business activities on human rights. The visit, from 7 to 16 December, took place against the backdrop of a serious environmental disaster, caused by the collapse on 5 November of a mining tailing dam in Mariana, State of Minas Gerais, and of a range of ongoing and planned large-scale development projects, including those related to the Rio 2016 Olympics.

#### Brutal Cartels Fight Over Mexico's 'Conflict-Free' Gold Revenues

Heroin traffickers linked to the abduction and disappearance of 43 students a year ago are battling over millions of dollars paid by Canadian mining giant Goldcorp to a village in Mexico's southern gold belt, leading to a wave of murders. As a signatory to a Conflict-Free Gold Standard drawn up by the World Gold Council industry group, Goldcorp (G.TO) commits to extracting the precious metal in a manner that "does not fuel unlawful armed conflict or contribute to serious human rights abuses."

But residents of Carrizalillo in the impoverished state of Guerrero say the some \$3 million a year in rent paid by Goldcorp for their land, which the mine is built on, is fuelling a bloody feud between two rival cartels. Village authorities say the company is not doing all it can to protect

#### • Fifa Appoint Harvard Professor to Improve Human Rights Policies

Crisis-hit Fifa has appointed John Ruggie to oversee an independent review that will recommend ways of embedding United Nations human rights protocols into its policies and practices. With labour abuses in Qatar under intense scrutiny in the run-up to the 2022 World Cup, Fifa and other sports governing bodies have come under pressure to consider the human rights implications of their hosting decisions. Amnesty International recently said that Qatar had yet to implement even the limited reforms that it promised in the wake of a series of investigations by the Guardian and international human rights organisations that unveiled the scale of the issue faced by the army of migrant workers in the country building the infrastructure to host the World Cup.
